In 2019, international arrivals in Asia and the Pacific increased in line with the world average of 4%

- Strongest growth in international arrivals since 2010
- 2nd most visited region in the world after Europe

- Largest decrease in international arrivals (-84%)
- Highest level of travel restrictions currently in place

UNWTO Expert Survey: When do you expect a rebound in international tourism in your country?



- **Mixed outlook**: Globally, on average, 50% of experts surveyed expect a rebound to occur in 2021
- For Asia and the Pacific, majority of experts expect a rebound in 2022

What are the main factors weighing on the recovery of international tourism?



- Many countries reintroduced **stricter travel restrictions** due to resurgences and emergence of new variants
- Mandatory testing, quarantines and in some cases, a complete closure of borders

Recovery remains contingent upon:

- Developments in the wider economy
- Easing of travel restrictions

- Health and Safety First good practices in health & hygiene, high-quality medical facilities
- The Trust Factor timely and accurate information ahead of and during travels
- **Destination Readiness in Remote Areas** strengthen infrastructure & protect local communities

3. INNOVATION & DIGITALISATION

- **Digital Boom** e-commerce, social media & mobile applications
- Contactless Convenience touchless technologies, contactless payment, biometric verifications & seamless travel experience
- The Rise of Virtual Tourism virtual experiences, simulations & live social media sessions

4. SUSTAINABLITY

- Environmental Protection preserving natural habitats and protected areas
- Crowd Moderation develop more remote offerings & alternative destinations
- Business Resilience multi-skilled and technologically adept workforce

- Targeted and accessible sector-specific support mitigate impact on workers, businesses & airlines
- Support small and micro enterprises (MSMEs) to adapt & survive
- Infrastructure investment upgrade facilities & public transport
- Travel incentives vouchers, rebates, discounts & packages

Coordinated Border Openings: Travel Corridor Arrangements & Harmonisation of Cross-Border Travel Protocols

- Bilateral arrangements to allow for essential & business travel
- Unilateral approach proposed for leisure travel when conditions permit
- Risk management & evidence-based approach to travel restrictions
- Standardisation of testing protocols & certification systems
